





COP24 in Katowice and COP25 in Madrid

COP24 had difficulties with closing the deals at the end of the conference, however the growing climate disaster statistics where alarming. There was no commitment about targets. Countries did not give up their industrial income against the needed carbon emission savings. At COP25 we concluded that we are entering the reality of a 3 till 4 °C temperature rise. China promised earlier a 40% savings, but ultimo 2019 U.N. reported a 66% raise! EU is targeting slow but are saving:



Climate tracker shows the status of the most emitting and it looks like there is much to gain: if countries want. UNEP reported that in 2019 just US\$ 70 million was contributed to the fund by only 42% of Members! Are they insane?

DRR and International Rescue are becoming most important now climate reacts extreme significant and countries don't proper react. WSF started a partnership with Riskmosaic.com from Washington USA, which will open an office in The Hague, early in 2020.

So, WSF as NGO produced over the years an Equity value of Euro 166 million. This besides her contributions to the market and over 360 volunteers. December 2019 an investor, a broker, and WSF agreed on a € 500,000 SBLC for a 40 weeks 100m PPP, with net fund of indicative 3.2B for WSF. This is roughly twenty times the Equity value. In Feb. 2020 the brokers bank started to prepare for contracts to sign mid-March. We don't like to take it for real before the funds are steady on our bank account, but we have a chance it will.

In general, WSF make the Principles part of her Check and Balances for participations, partnerships, customers, and her service value chain. We communicate our UNGC membership actively.

Human Rights

Basically our development departments are volunteer staff filled with 14 till 21 hours work per week. Project and production staff works 28 till 35 hours max. To let all of them participate in decision making we apply Holacracy as management system that offers task flexibility. 5: the effective abolition of child labor; We demand value chain responsibility for this matter from our suppliers and resellers. In our own Program based projects we keep board and management positions, which C&B on this. and 6: the elimination of discrimination in respect

7: Support a precautionary approach to environmental challenges;

WSF addressed The Peace Palace in The Hague to become, and report, her sustainable efforts.





Late 2019 WSF got introduced by Francis Knize to WaSoRe – Water Soil Regeneration CEO Bruce Vinkemulder. Now we work together to make offers and get funds to contract twenty-five countries with a thirty years' water and soil regeneration delivery service. Namibia, Somaliland, and Sahel G5 will be the first:

Early in 2020 WSF became an official partner of NATO Common Effort and member of the Core Development Team for the Sahel G₅.


